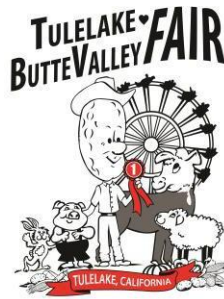
PUBLIC PARTICIPATION
